Whereas the king heretofore assigned in dower to Eleanor his consort the castles of Tykehull and Stanford and certain manors in England, and certain castles and manors in Gascony, and also lately while he was in Gascony, at the instance of her brother Alfonso, king of Castile, granted to her land to the value of 4,000*l.* yearly, and afterwards, of his grace, granted her further land to the value of 500*l.* yearly, so that she should have in the whole, both in England and Gascony, land to the value of 4,500*l.* yearly; the king, of his further grace, has granted to her Blanquefort (*Blankeford*) L'isle de Macau (*Insulam Marketum*), and Castelnau (*Novum Castrum*) and all other lands which may fall to the king by the death of the lady of Blankeford, to hold in dower, for life, in completion of the said assignment.

Grant to her of the manor of Burstwik, with the town of Hedon, in dower, in compensation for the wapentake of Wirkesworth and the town of Asseburn; formerly assigned to her in dower, but afterwards granted to Edmund, the king's brother, in exchange for the castles of Carmarthen and Cardigan.

June 10. Grant, for life, to Ralph le Mareschal, in consideration of his service to
[Westminster.] Eleanor the king's consort, of a shop in Bristol, heretofore granted, for life, to Peter le Barbur, deceased.

Commission *de wallis et fossatis*, during pleasure, to the sheriff of Essex, in the marshes of Westhamme, on complaint by the abbot of Stratford that his neighbours neglect to repair the same, or to contribute to the repairs which he makes yearly, to the danger of inundation by the waters of the Thames and the Lea (*Luye*).

Protection with clause *volumus* to William de Audeley, Geoffrey de Skeftenton, John de Baskerville, William de Bruera, John Devereus, Roger le Burgyloun and Nicholas Dod, going to Ireland.

Simple protection, for three years, in Ireland for Walter de la Haye.

Pardon to John de Carewell of his outlawry for the robbery of Peter de Sancto Petro of Bordeaux at Blakene, co. Norfolk.

June 10. Letters for Richard de Crepping, going beyond seas on the king's
[Westminster.] service, nominating Gilbert de Whiteby his attorney until Michaelmas.

Licence for Henna daughter of Leo de Eboraco and Elias her son, Jews of York, to sell to Henry de Brylaund a house of theirs in that city situated in Conigstrete, to hold in the manner specified in a charter made by the said Jews to the said Henry.

Protection with clause [*volumus*], until Christmas, for Richard de Crepping, going beyond seas on the king's affairs.

The like, for three years in Ireland, for John de Aveynes and Agnes his wife, staying beyond seas.

Mandate to Gregory de Rokesle and Orlandinus de Podio, keepers of the Exchange of London, to pay to Maurice de Credonio out of the new money 300*l.* for the custody of the lands and heirs of Roger de Monte Alto, which he has sold to the king and which the king formerly gave him.

Mandate to the English in Ireland to assemble some time before the Nativity of the Virgin Mary to consider among themselves if the recent petitions of the Irish in Ireland to the king, that they may be allowed to enjoy the same laws and customs as the English therein will be to the prejudice of the latter or not, and to make known the result to the king, with their counsel before his next parliament at Westminster a month after Michaelmas under the seals of the justiciary of Ireland, or such as supplies
