Norfolk and marshal of England, of a charter of the earl, dated at Chilhith, 11 (*sic*) October, 33 Edward I. confirming to John de Uffeton, his chamberlain, for life, the custody of all his parks and woods of Framelyngham, Killeshale and Saham, co. Suffolk, with 4*s.* a week for the custody, 20*s.* a year for his robe, hay and oats for one horse, to wit, every night half a bushel, all trees blown down by the wind, and escheats of timber given or felled to the earl's use.
