July 1. Protection, until Christmas, for Peter de Cusancia, staying in Gascony with the earl of Richmond on the king's service.
- July 1. The like for Peter de Grandisono, staying in Gascony as above.
Peter de Cusancia, staying in Gascony as above, has letters nominating Gerard de Cusancia and John de Coton his attorneys for the same time.
Peter de Grandisono, staying in Gascony as above, has like letters nominating Robert de Kersbroke and John de Coton his attorneys.
- July 2.
Berwick-on-Tweed. Grant to John de Warena of all ransoms, fines, and amercements arising out of a commission to William de Ormesby, William de Colneye and Richard de Walsingham, or any two of them, to hold an enquiry touching a breach by divers persons of the earl's park of Gymyngham, co. Norfolk, and of his free warrens there and at Methelwold, who also broke his weirs at Rademere, Helegye, and Welles, in the same county, fished his free fishery and stews, and carried away a whale cast on shore at Brunham, within the precincts of his hundreds Galehowe and Brothercros in that county. - July 6. Presentation of John de Trydian of Cornwall to the church of Theberton, in the diocese of Norwich. By p.s.
- July 1.
Berwick-on-Tweed. Acquittance to the abbot and convent of Glastonbury, sub-collectors in the diocese of Bath and Wells of the tenth imposed for three years by pope Boniface VIII. on the clergy of England, upon payment into the Exchequer by the hands of J. bishop of Bath and Wells, of 6*l.* 10*s.* on account of the arrears of that tenth. By bill of Exchequer.
The like to the same abbot and convent, upon payment of 24*l.* 11*s.* 10*d.* on account of the same arrears. By bill of Exchequer.

- June 4.
Berwick-on-Tweed. Grant, for a term of five years, to the bailiffs and good men of the town of Newcastle-on-Tyne, of murage, to be levied by Richard de Emeldou, Nicholas de Ellerker, John de Ellerker, Laurence de Dunelm and John de Eyville, burgesses of the town, who are to account for all sums of money received for that purpose. By p.s.
- Jan. 11.
Berwick-on-Tweed. *Inspeximus* and confirmation of a grant for life by queen Isabella, 13 December 1310, to John de Foresta, her clerk and notary of her household, canon of the church of St. Wlfran, Abbeville, of the house which Sir Nicholas Pohier, formerly a canon of the same church, had held of the queen and of the late king, in the street called St. Giles, Abbeville, free from rent or rendering any service for it. By p.s.
- July 1.
Berwick-on-Tweed. Grant to George Selveyn, king's clerk, of the prebend of Neuthorp in the church of St. Peter, York, in the king's gift by reason of the late voidance of the see of York. By p.s.
Mandate in pursuance to W. archbishop of York.
- July 4.
Berwick-on-Tweed. Pardon to William le Corveiser of Hereford for having enfeoffed, without licence, his son William of houses and a cellar in Hereford, formerly held by William son of William le Mercer, which, on account of a felony committed by him, had been escheated into the hands of the late king, by whom, in consideration of a fine, the same had been granted to the above-mentioned William le Corveiser, subject to a rent of 37*s.* a year. By fine of 40*s.*
- July 6. Protection, until Michaelmas, for Henry de Bureford, parson of the church of Ringgesfeld.
