Nov. 2. Windsor. Richard le Fessu, the king's butler, staying in England on the king's service, has letters nominating Walter de la Sale and William le Petit of St. Hilary, his attorneys in the islands of Gernereye and Gereseye for two years.

- Nov. 2. Windsor. Licence for the alienation in mortmain to the abbot and convent of St. Werburgh's, Chester, by Henry de Bromburgh, of one bovate and a rood of land, and 4s. 6d. of rent in Chester and Kirkeby in Waleye; and by Robert de Assheburne of a messuage in Chester. By fine of 100s.
- Oct. 11. London. Presentation of Robert de Bardelby to the church of Munketon-on-the-Moor, in the diocese of York, in the king's gift by reason of his custody of the lands of Robert Ughtred, deceased, who held of the heir of Philip Paynel, tenant in chief, a minor in the king's custody.
- Nov. 6. Sheen. Grant, at will, to queen Isabella of the manor of Eltham, co. Kent, and all lands in Craye, Cateford and other adjacent towns, which the king has of the gift of Anthony sometime bishop of Durham. By K.
- Nov. 11. Westminster. Prohibition of a tournament at Northampton. [*Fœdera.*] By K.
- Protection, for one year, for Laurence de Campania, parson of the church of Nayleston.
- Nov. 2. Windsor. Licence for Adam de Everingham, to grant the manors of Laxton, co. Nottingham, and of Westburgh, co. Lincoln, held in chief, to Thomas de Suwelle, chaplain, and for the latter to regrant them to him and Claricia his wife and his heirs. By p.s.
- Nov. 9. Westminster. Writ *de intendendo* for Geoffrey de Sutton appointed during pleasure by Walter de Waldeshef, the chief butler, to be his deputy in the port of Boston.
- Nov. 16. Westminster. The like for the under-mentioned, viz.—  
William de Molendinis for the port of Portesmuthe.
- Nov. 11. Westminster. Grant, during pleasure, to Arnold de Tilio, king's clerk, of the office of the Marshalsea at the Exchequer. By K.
- Nov. 2. Windsor. Licence for John de Pelham, king's clerk, to crenellate his dwelling-houses in Silverstrete and Distaflane in the city of London. By p.s.
- Nov. 10. Westminster. Gift to queen Isabella, in enlargement of a former grant to her of the manor of Eltham, co. Kent, and of lands in Craye and Cateford and other adjacent towns, which the king has of the gift of Anthony sometime bishop of Durham, of all goods which were in the manor and lands at the date of the grant. By p.s.
- Nov. 11. Westminster. Licence for the alienation in mortmain by Simon de Kent of Beverley to W. archbishop of York, of 4s. of rent in Beverley, in compensation for a rent of 4s., which the prior and Friars Preachers of Beverley were accustomed to pay to the archbishop, and which the archbishop and the chapter will release to them.
- 4 Edward II. Berwick-on-Tweed. Pardon to John de Penreth for acquiring in fee, without licence, from Gilbert Mac Askil, 120 acres of the waste land in the old park of Aukland in the bishopric of Durham, during the voidance of the see. By p.s.
