Grant to the mayor, sheriffs and citizens of London, to whom the king, 18 July, 4 Edward II., had made a previous grant of murage for a term of three years, and afterwards, 15 September, 6 Edward II., had granted licence to them to collect upon the determination of that term the same customs for a further period of one year for the construction of a tower, by the dwelling place of the Friars Preachers of London, at Baynard's Castle upon the bank of the Thames, in extension of the former grants of pavage, that they may take for the term of one year the same customs for the rebuilding and repairing, by view and ordinance of the keeper of the gate of Newegate, of the enclosure of that gate and the gaol there, and also of certain chambers which are in a ruinous state to the injury of the city of London, and danger of the escape of prisoners who are in that gaol. By K.

Mandate to the mayor, sheriffs and other citizens to cause the said enclosure and chambers to be rebuilt and repaired, by view and ordinance of Ralph Sporun, keeper of the gate, out of the moneys accruing from the customs above granted. By K.

Licence, after inquisition *ad quod damnum* made by Hugh le Despenser, late keeper of the forest on this side Trent, for the abbot and convent of Waverle to enclose with a little dyke and low hedge, according to the assize of the forest, 40 acres of their wood of Dokenesfeld, which is within the metes of the forest of Woluemere. By fine of 20*s*.

Writ of aid, until Midsummer, for John de Sturmy, whom the king is sending to the county of Norfolk to bring two ships of his, of which the one is called '*la Cristofre*' and the other '*la Jonette*,' and which are lying outside port on the high sea, not without danger as the king hears, into the port of Oreford, or Orewelle, or any other port in those parts, as shall seem best to be done.

Acknowledgment that the king has received at the Exchequer from the abbot and convent of Oseney 40*l*. as a loan, which sum of money he promises to repay out of the tenth granted to him by the clergy in the bishopric of Lincoln, or out of the twentieth or fifteenth granted to him by the laity of the county of Oxford.

The like acknowledgment for 40*l*. to the abbot and convent of Abyndone, to be repaid out of the tenth in the bishopric of Salisbury, or the twentieth, &c., in the county of Berks.
