and service of Drogo de Barentyn for the fourth part of a knight's fee held by him in Hernestede, and the manors of Westerham and Edenebregge, co. Kent, the manor of Turveston, co. Buckingham, and the manors of Knolle and Grafton, with the hamlets of Alspathe, Buleye, Hulverlee, Wytlikesfeld, Kynewaldeshey, Notehurst, Langedon and Didington, co. Warwick, to hold for pious uses, and Edward I. further ordained that the said prior and convent should make ordinances for such uses according to his vow, whether the abbacy was filled or void, Edward II. at the request of John de Wytteneye, a monk of the said house and keeper of the said manors and hamlets, and further wishing to do a favour to the prior and convent, the abbacy being void, grants that they, the abbacy being void, and future abbots may acquire in mortmain lands, tenements and rents, which are held of them as of the said manors and hamlets, to the value of 10*l.* a year according to their true value, in augmentation of maintaining pious works and divine worship for the soul of the king's mother, his own soul, and the souls of his ancestors and heirs. July 27. Grant to the king's merchants, Duffus Barde and Roger Ardyngelli and Thundridge. their fellows, merchants of the society of the Bardi of Florence, that they may retain 109*l.* 4*s.* out of the moneys received by them accruing from the aid granted by the nobles and commonalty of the duchy of Aquitaine in the subsidy of the war with Scotland, in satisfaction of the same sum paid by them to James Beauflour for wax and spices bought for the king's use, for which an allowance will be made to them in their account. If there shall be any deficit, the same shall be made good to them before Michaelmas out of the issues of the realm. By K. on the information of the Treasurer.

July 22. The like to the same Duffus Barde and Roger Ardingelli and their Westminster. fellows, merchants of the society of the Bardi of Florence, for 100*l.* paid by them to Elias Begger, citizen and merchant of Bordeaux, for corn bought from him for the king for the munition of the town of Berwick.

July 31. Mandate to Master John Waleweyn, escheator on this side Trent, or his Melchbourne. sub-escheator, in the county of Leicester, for the restitution of the temporalities of the abbey of Osolveston, to Robert de Staunford, canon of that house, whose election as abbot thereof J. bishop of Lincoln has confirmed.

Writ *de intendendo* for him, directed to the knights, free men and tenants of the abbey.

July 24. Grant, after inquisition *ad quod damnum*, made by Master John Westminster. Waleweyn, king's clerk, escheator on this side Trent, to John de Sandhulle and Christina his wife, that they may hold to them and their heirs from queen Margaret, so long as she shall live and after her death from the king and his heirs, 2 messuages, 80 acres of land, and 6 acres of meadow in Gillyngham, which are accustomed to be held according to the custom of the manor of Gillyngham, which manor is of the ancient demesne of the crown, and is held for life by queen Margaret of the grant of Edward I., although it appears that no charter had been obtained from the king or his progenitors, and that the king will make them such charter, also that the said messuages, lands and tenements were hitherto held from the king's progenitors, and are now held from queen Margaret by the service of rendering 1*l.*s. in equal portions at Michaelmas and Easter and by doing suit at the court of the Barton (*de Bertona*) of the manor every three weeks. Aug. 5. Signification to W. archbishop of Canterbury of the royal assent to the Lincoln. election of John de Sandale to be bishop of Winchester.
