- May 22. Westminster. Mandate to the canons of the king's free chapel of the castle of Hastynges to assign a stall in the choir and a place in the chapter to Master John de Stratford, king's clerk, whom J. bishop of Chichester has admitted on the king's presentation to the prebend of Stone in the said chapel.
- May 20. Westminster. Licence for the alienation in mortmain by the abbot and convent of Kirkestede to the dean and chapter of the church of St. Mary, Lincoln, of the advowson of the church of Thymelby by Horncastre, co. Lincoln; licence also for the dean and chapter to appropriate the said church. By p.s.
- May 20. Westminster. Licence for the abbot and convent of Kirkestede to appropriate in mortmain the church of Covenham, co. Lincoln, which is of their own advowson. By p.s.
- May 23. Westminster. Licence for the vicars of the church of St. Mary, Salisbury, in augmentation of their commons by $\frac{1}{2}d.$ a day each above what they receive for their sustenance, to acquire in mortmain lands, tenements, and rents or advowsons of churches to the value of 40*l.* a year according to their true value, and also to appropriate such churches. - May 26. Westminster. Presentation of Thomas de London to the church of Chelwentou, in the diocese of Lincoln.
- May 1. Windsor. Exemption, for life, of William de Boyton from being put on assizes, juries, or recognisances; and from being made sheriff, coroner, or other minister of the king. By p.s.
- May 24. Westminster. Licence for John de Hastynges to grant his manor of Lymmyng, which is a member of his manor of Brampton, and is held in chief, as appears by inquisition made by Master John Walewayn, king's clerk, escheator on this side Trent, to William de Brom and Ascelina his wife and John son of the said William for their lives. By K.
- May 24. Westminster. Licence for John de Hastynges to grant 10*l.* of rent in Belchesford, Wadyngton, Colkesby and Donyngton, held in chief, as appears by inquisition made by Master John Walewayn, king's clerk, escheator on this side Trent, to William de Brome for life. By K.
- May 15. Windsor. Licence for Reginald de Clifford to enfeoff Peter de Clifford and Isabella his wife of the manors of Middelrocumbe and Cumbe in Tynhyde, co. Devon, held in chief. By fine of 40*s.*
- May 26. Westminster. Agreement between the king and Thomas de Multon, lord of Egremont, for a marriage between John, eldest son and heir of the said Thomas, and Joan daughter of Piers de Gavaston, sometime earl of Cornwall, when they shall be of a reasonable age. *French.* [*Fœdera.*] By K.
- May 27. Westminster. Protection, with clause, until Michaelmas, for W. bishop of Exeter, who has remained since Easter in London at the king's side on business of the king. By K.

- May 26. Westminster. Grant to the mayor, sheriffs and other citizens of London of murage upon all wares brought for sale into the city, for two years, in aid of the completion of a new tower on the city wall by the dwelling place of the Friars Preachers, lately begun and not yet finished, and of the enclosure of the city; but during the continuance of the pontage granted by Edward I. murage is not to be levied upon any merchandise or wares for sale passing over or under London bridge upon which pontage is levied.
