Sept. 24.  
York. Safe-conduct, during pleasure, for Master Rigaud (Rigald) de Asserio, canon of Orleans, professor of Civil Law, the nuncio, whom Pope John XXII. is sending to England, Ireland and Wales, and also for the sub-collectors and ministers whom he shall appoint to act for him. [*Fœdera.*]
- Sept. 25.  
York. Assignment to John de Mowbray, to whom the king is bound in the sum of 500 marks, of 300 marks to be received out of the farm of the town of Bedeford, and 200 marks out of that of the castle and honor of Knaresburgh, in full payment of the above sum. By p.s.  
Mandate in pursuance to the bailiffs of the town of Bedeford.  
The like to the keeper of the said castle and honor.  
Licence for Geoffrey Lescrope to crenellate his dwelling place of Clifton-upon-Yore, co. York. By K.  
Grant to Roger Damory, and Elizabeth his wife, the king's niece, of the castle of the Salmon Leap in Ireland with its knight's fees, advowsons of churches, &c. to hold for their lives with remainder to the first-born son of the said Roger and Elizabeth for his life, with subsequent reversion to the king and his heirs. By K.  
Mandate in pursuance to Roger de Mortuo Mari of Wygemor, keeper of Ireland, to deliver to them the castle with its armour, victuals, &c.  
Writ *de intendendo* for them directed to the knights, free men, and other tenants of the castle.

- Sept. 20.  
York. Writ of aid, until Christmas, for Thomas Seintclere and James le Curer, the servants whom Gaucelinus, cardinal priest of SS. Marcellinus and Peter, is sending to divers places to buy corn and other victuals for his household.
- Sept. 20.  
York. Protection, for one year, for certain burgesses of the town of Berwick-upon-Tweed, going to divers parts of the realm and also to France to purchase corn and other victuals and to carry the same to Berwick for the provisioning of that town; the burgesses have letters, under the common seal of the town and under the seal belonging to the office of the chamberlain there, testifying that they have been appointed to do so. Further they have given sufficient security that they will not carry such provisions elsewhere or to the king's enemies. By K.  
*Inspeximus* and confirmation of the under-mentioned charters and inspections, viz.—
- Sept. 13.  
York. I. Charter by which Ranulph, sometime earl of Chester, granted all the land which he held in Tiwe with its capital messuage and the donation of the church there, excepting the land late of Hugh de Colonciis in that town, to John de Pratellis, for his homage and service, to hold to him and his heirs by the service of a fourth part of a knight's fee; witnesses, earl Hugh de Laci (*Hugone Comite de Laci*), Philip de Orreby, Thomas Dispenser (*Dispensario*), Walter de Coventre, Hugh Malebille, Norman Pantull', William de Verdun, Alvred de Suluigni, Henry Murdach, Henry Dispenser, Hugh Dispenser, Thomas Dispenser, Philip del Bye, William de Venables, Warin de Verun, William the Butler (*pincerna*), the steward of Mold (*sen' de Monte Alto*), Thomas the Clerk (*clerico*), Payn de Chaurc [*iis*] and others.
