Sept. 25.
York. Grant to William de Ros of Hamelak, who had surrendered and quit claimed to the king his castle of Werk-upon-Tweed together with its knights' fees, serjeanties, homages, services of free tenants, villeins and their villeinages, and all other appurtenances, excepting the advowsons of cells pertaining to the priory of Kirkeham and to the hospital of Boulton, in exchange for 400 marks of land and rent a year to be granted before mid-summer to him and his heirs in suitable places between the rivers Thames and Thaysse, as the king wishes to provide security for him, of 400 marks of rent a year out of the farms of the cities of York and Lincoln, viz. from the city of York 120*l.* and from the city of Lincoln 146*l.* 13*s.* 4*d.*, to be received by the hands of the bailiffs of the said cities to hold to him and his heirs until the king shall provide the said 400 marks of land and rent and enfeoff him or his heirs thereof: further if it happen that the said William de Ros and his heirs shall by judgment of Court be removed from any of the lands to be assigned to them, they shall be provided with other lands and tenements in place thereof. York. Appointment, during pleasure, of John de Moubray to the custody of the castle of Scardeburgh with the usual fee.
Mandate to Taylefer de Tyle to deliver to John de Moubray the said castle with its armour, victuals, stock, &c. which are in his custody.

York. Presentation of Nicholas de Sutton to the church of Hyntlesham in the diocese of Norwich. By K.
- Sept. 28.
York. Grant to the abbot of St. Mary's, York, to whom the king is bound in 200*l.* which at his request the abbot paid to Henry son of Hugh in part satisfaction of the king's debts to him, that out of the tenth last granted in the diocese of York and to be levied by the abbot, who is one of the collectors thereof, and of the arrears thereof and also out of the first tenth to be levied in the said diocese, he may raise 200*l.* for his own use and retain it, for which an allowance will be made in his accounts.

York. Licence for William de Monte Acuto to crenellate his manor of Kersington, co. Oxford. By K.

York. Protection for the earl of Lancaster, his followers and adherents, granted at the request of the earls of Pembroke and Hereford: freedom from arrest and seizure shall continue so long as Parliament shall sit: all matters which can be redressed in Parliament shall be redressed accordingly, and other matters by law of the realm. *French.* [*Parl. York. Power to the earls of Pembroke and Hereford to discharge the followers and adherents of the earl of Lancaster and to restore their goods, lands and tenements, if the same have been arrested or seized: they are authorized to appoint deputies to act for them: the commission is to last until the quinzaine of St. Hilary and during the time of the Parliament. *French.* [*Parl. York. Grant to Richard le Mareschal, who has suffered many losses through the Scots, of 50*l.* a year in aid of his sustenance, until the king shall make other provision for him or until he shall again obtain possession of his lands, to be received by the hands of the escheator beyond Trent out of the issues of his bailiwick.
