 July 10. Northampton. Licence for the alienation in mortmain to the prior and convent of Spaldyng by Clement de Hatfeld, vicar of the church of Pyncebek, and Peter de Hatfeld of a messuage, 9 acres of land, and 3 acres of meadow in Obthorpe and Thurleby, held of the said prior and convent, and which are worth in all their issues 2s. a year, as appears by inquisition made by Master John Walewayn, escheator on this side Trent, in part satisfaction of a licence granted to them to acquire lands and tenements to the value of 20*l.* a year.
- July 13. Northampton. Safe-conduct, until Christmas, for the envoys of R. count of Flanders, coming into the realm to treat of the losses suffered by the men of Flanders and the king's subjects. [*Fœdera.*]
- July 16. Northampton. Protection and safe-conduct for the same time for merchants and others of Flanders coming into the realm to trade. [*Fœdera.*]
- July 15. Northampton. Licence, at the request of queen Isabella, for Laurence de Pavely to enfeoff Ralph, parson of the church of Pyry, of his manors of Pyry and Hoghton, held in chief as of the honor of Peverel, as appears by inquisition made by Master John Walewayn, escheator on this side Trent, and for the feoffee to regrant the same to the said Laurence for his life, with remainder to Robert, son of the same Laurence and his heirs. - July 13. Northampton. Safe-conduct until Christmas for Siglaf Susse, burgess of Lenne and for a ship, called *la Godiere* of Gernemuthe, which he is sending to Norway for masts (*pro malis*) and other goods to be brought from thence into England. By K. on the information of Roger de Northburgh.
- July 15. Northampton. Licence, after inquisition *ad quod damnum* made by Master John Walewayn, king's clerk, escheator on this side Trent, for the alienation in mortmain by John Godhyne of Marlebergh of a messuage, 60 acres of land, 2 acres of meadow, and 20s. of rent in Berton by Marlebergh to the prior and canons of the house of St. Margaret by Marlebergh to find a canon to celebrate divine service daily in their church for the soul of the grantor, and the souls of his father and mother and of all Christians; the said messuage, land and rent are held in chief by the service of [rendering] every year 8s. and 4 capons of the price of 8*d.*, and of doing suit at the court of Berton by Marlebergh every three weeks. By fine of 10 marks.
- July 12. Northampton. Licence for the abbot and convent of St. Mary's, York, to crenellate their abbey, which is without the city of York, but is contiguous thereto, provided that the wall to be constructed between the abbey and the wall of the city shall not exceed 16 feet in height and shall not be crenellated. By K.
- July 12. Northampton. Acknowledgement that the king has received as a loan by the hands of Robert de Barton, king's clerk, keeper of the king's victuals at Carlisle, from J. bishop of Lincoln, in the name of Pope J[ohn] XXII. the sum of 100*l.* out of the tenth for six years for the general crusade collected in the city and diocese of Lincoln, with promise of repayment within five years. *Vacated because surrendered and cancelled.* By K.
- The like for L. bishop of Durham for 100*l.* collected in the city and diocese of Durham. *Vacated as above.*
- July 13. Northampton. Licence for Aymer de Valencia, earl of Pembroke, to grant in fee, or to demise for life, to whomsoever he will, his manor of Shelford, co. Cambridge, held in chief. By K.
