Michael de Huleston, rector of the church of Menestok, William de Staunford, rector of the church of Westmene, and Henry de Lyskeret, rector of the church of Wydehaye, executors of the testament of John de Pontisara, bishop of Winchester, in the sum of 233l. 6s. 8d. sterling, received as a loan by Roger de Northburgh, king's clerk, keeper of the Wardrobe; with promise of repayment before Michaelmas.
