York. York. Grant to the Carmelite Friars of Scardeburgh of the two houses in Scardeburgh, which the king held of the gift of Robert Wauwayn, to construct an oratory and houses in which the said Friars can dwell. By p.s.
- Aug. 24.  
Fenham. Grant to Isabella de Bello Monte, lady of Vescy, that no distraint shall be made in the manor of Ingmanthorpe, which she holds for a term of years of the demise of William de Ros of Ingmanthorpe, for the debts in which the said William is bound to the king at the Exchequer, and that she may hold the manor until the end of that term quit of all demands for the said debts, provided the said William has sufficient lands and tenements elsewhere, whereof the debts can be levied. York. Grant to the bailiffs and citizens of York, for a term of ten years, of pavage and murage upon all wares for sale brought into their city. By K.

York. Grant to John de Foxle, a baron of the Exchequer, in consideration of his meritorious services, that henceforth he may attend to his own business and reside in his house, as often and as long as it shall seem good to him
