- Oct. 29. Nottingham. Licence for Henry de Edenestowe to purchase or take by gift from religious persons or others having woods in Shirwode Forest twenty oaks fit for timber, and to carry them away through the forest. By p.s.
- Oct. 28. Nottingham. Prohibition to all ecclesiastical persons and others from proceeding in derogation of the king's right to collate Robert de Swynnerton to the deanery of the king's free chapel of Stafford, and of the possession of the same by the said clerk.
- Oct. 28. Nottingham. Mandate to sheriffs and others to arrest all persons disobeying the said prohibition.
- Oct. 15. Nottingham. Mandate to sheriffs and others to arrest all persons proceeding in derogation of the king's right to present to the church of Mottrum, in the king's gift by reason of the lands of Robert de Holand being in his hands, and of the possession of the same by John de Wodehous, king's clerk.
- Oct. 30. Nottingham. Appointment of Robert Power, king's clerk, to the office of treasurer of the Exchequer in Dublin, during pleasure. By p.s.
Mandate to John de Cogan to deliver to him the rolls, keys, memoranda and other things pertaining to the office.

- Oct. 12. Nottingham. Licence, after inquisition *ad quod damnum* in Lincolnshire, for Thomas de Sibethorpe, parson of the church of Bekyngham, to enclose, for the enlargement of his rectory house, a certain way running below it towards the west, provided that he make another convenient way instead thereof. By K.
- Oct. 20. Nottingham. Writ of aid, until Easter next, for Andrew de Apethorp, king's yeoman appointed a purveyor of the household. By bill of wardrobe.
- Oct. 18. Nottingham. Protection, with clause *nolumus*, for one year, for Andrew le Irish' merchant, travelling for the sale of his merchandise.
- Oct. 20. Nottingham. Grant to Bartholomew de Burgherssh of the custody of the castle of Ewyas Lacy, in Wales, and the manor of Hethe, co. Oxford, during the minority of the heir of Theobald de Verdon, deceased, tenant in chief. By K.
- Oct. 20. Nottingham. Writ of aid for Nicholas Shirlok, king's yeoman, to whom was granted by letters patent, dated 10 June last, the office of alnager of cloth in England, for life.
- Oct. 22. Nottingham. Richard de Warrewyk, staying in England, has letters nominating James Laweles, clerk, his attorney in Ireland for one year.
- Oct. 23. Nottingham. Licence, at the request of Burga de Vallibus, for the abbot and convent of St. Benet Holme to protect the site of their abbey with a wall, and crenellate the same. By p.s.
- Oct. 23. Nottingham. Pardon, at the request of queen Isabella, to Richard le Brun, late mayor of Chester, for adherence to Douenald de Mar, an enemy and rebel. By p.s.
- Oct. 18. Nottingham. Licence, at the request of John de Stonore, for the alienation in mortmain by Robert de Abyndon to the abbot and convent of Redyng, of four messuages and a stone quay in London, held in chief, to find two secular chaplains to celebrate divine service daily in the chapel of the Virgin, within their abbey church, for the souls of Master Richard de Abyndon, his ancestors and heirs and others. - Oct. 23. Nottingham. Grant that no public woman shall dwell in the town of Cambridge or the suburb thereof, and that on the complaint of the chancellor or vice-chancellor (*vicegerens*) of the University, proclamation shall be made by the mayor and bailiffs of the town four times a year, or oftener if need be, and
