and rent which they had the late king's licence to acquire, of a carucate of land, 3 acres of meadow, 8s. of rent and a rent of *1lb.* of cumin, in Seybrok, and Pychelesthorn, held of the rector, and the reversion of a carucate of land, 2 acres of wood, and 20s. of rent, in Pychelesthorn, likewise held of the rector, which Richard de Donewale and Alice, his wife, hold for her life. The said land, meadow, wood and rent of cumin are worth 55s. $1\frac{1}{2}d.$ yearly, as has been found by inquisition taken by Peter de Saldford, escheator in the county of Buckingham.

July 15. Licence for the alienation in mortmain by the prior and convent
Westminster. of Launde, co. Leicester, of 10*l.* of rent out of the priory and all its lands in Lodyngton, Tilton, Friseby, Welham and Norton, in the same county, to a chaplain, warden of a chantry at the altar of St. Mary in the chapel of Chaddesdene, co. Derby, and two chaplains, his fellows, to celebrate divine service daily at the said altar, for the good estate of the king, for his soul, when he is departed this life, for the soul of Master Henry de Chaddesdene, late archdeacon of Leicester, and for the souls of his ancestors. July 16. Protection for two years for the priory of Hevenynges, co. Lincoln,
Westminster. the prioress and nuns, and their men and servants, goods and possessions, as the king has learned that, although the priory is so poorly endowed that there is barely sufficient for the sustenance of the inmates, some evil doers have carried away by force of arms the goods of the prioress, and by threats daily prevent the men and servants deputed to collect the crops, hay and grass arising out of the tithe of their church of Hevenynges as well as out of their demesne lands from carrying the same to the priory; and that they have imprisoned the said men and servants.

July 6. Appointment of Master John de Peismersh, William le Spycer
Westminster. and John Stouk to take in the county of Kent carpenters, masons and other workmen for repair of the walls of the castle of Ledes, which have lately fallen down in great part, and to put them to work at the wages of Queen Isabel as long as shall be necessary. By C.

July 25. Presentation of Gregory de Tregruk, parson of the church of
Westminster. Bryngwyn, in the diocese of Llandaff, to the church of Lanvyhangel Estymllewhryn, in the same diocese, in the king's gift by reason of his wardship of the lands and heir of Laurence de Hastynges, late earl of Pembroke, on an exchange of benefices with John de Bella Aqua.

Presentation of the said John to the church of Bryngwyn, in the king's gift as above.

July 30. Licence, for 10 marks to be paid to the king by Thomas de
Westminster. Pakenham, 'chivaler,' for the said Thomas to enfeof John de Ufford, 'chivaler,' John de Nevill, 'chivaler,' William de Wychyngham, John de Cavendissh and John de Gunevill, clerk, of the manor of Walsham, co. Suffolk, held in chief.

Aug. 3. Signification to R. bishop of Coventry and Lichfield, of the royal
Westminster. assent to the election of Henry de Alston, monk of the house of St. Peter, Shrewsbury, to be abbot of that place.
