- July 15. John son of Warin Tirell, staying in England, has letters nominating Thomas son of James le Petyt and Robert son of Roger Tirell as his attorneys in Ireland for two years.
Westminster. David de Woll[ore] received the attorneys.
- July 8. Grant to Peter de Brewose, Adam de Wyche, William Kymbel and Robert Daunz, chaplains, their heirs and assigns of the manor of Qwhitford, co. Devon, held in chief, with all appurtenances and a moiety of the hundred of Coliton, as lately granted to the king and his heirs by the said Peter and Joan his wife (*see p. 271*), and with the issues and profits of the manor while in the king's hands by virtue of such grant. By p.s.
Westminster. *Vacated because otherwise above under the same date.*
- July 18. Presentation of Richard de Evesham, prebendary of the prebend Northfleet. which James de Molyns had in the church of St. Mary, Condet, in the diocese of Cambrai (*Caneracens'*) to the church of Suthfeld, in the diocese of Norwich, in the king's gift by reason of the lands late of John de Segrave, and Margaret, his wife, of her inheritance, having been taken into his hands on account of the death of the said John, who held in chief; on an exchange of benefices with Master Peter de Aysne. - July 20. Presentation of John de Littelton, chaplain, to the church of Northfleet. Lidyerd Milsent, in the diocese of Salisbury, void by the resignation of Richard de Evesham, last parson thereof, and in the king's gift by reason of the priory of Newent being in his hands on account of the war with France.
- July 22. Licence to elect for the prior and convent of the house of St. Peter, Westminster. Shrewsbury, on news brought to the king of the death of Adam de Clubury, their abbot.
- July 1. Joan de Lebret, sister of Bernard de Lebret, William Sancii, lord of Westminster. Pommiers, Master Gerald de Podio, preceptor of Arveyres, Arnold de Pontibus of the order of the Friars Minors of Bordeaux, guardian of the Friars Minors of Rions, Raymond Bovis, canon of Vertheuil, Arnold de Piolio, reader of the Augustinian Friars of Bordeaux, and Peter du Bers, called Peironon, executors of the will of the said Bernard, have attorned before the king John de Stodeye, citizen of London, and Robert de Orcheston to receive moneys due to him and make acquittances thereof, and to cause any recognizances and obligations to him to be cancelled.
Master Bernard de Saltu received the attorneys by writ.
- July 20. Appointment of John de Alkeshull to purvey timber, stone, iron, Westminster. lead, tiles, fuel and other necessaries, for the Tower of London, the palace of Westminster, the castle of Wyndesore and the town of Calais, wherever in England shall seem to be expedient, and carriage for the same.
