Dec. 11. Mandate to John atte Wode, escheator in the county of Salop, Westminster. to deliver the temporalities of the abbey of St. Peter, Shrewsbury, to Nicholas Stevens, monk of the house, whose election to be abbot of that place has been confirmed by Robert, bishop of Coventry and Lichfield, and who has done fealty.
