Chydiok, 'chivaler,' and Edmund de Chelreye, on complaint by John, bishop of Bath and Wells, the treasurer, that whereas the king took him, who is daily occupied about the direction of affairs affecting the state of the realm, and his men, lands and rents, into his special protection, Roger Carpenter of Shyrburn, Roger Seward of Dorchestre, Laurence Janyn of Melcomb, Henry 'Stevenservant Hayne' of Winchester, Robert 'Philipservant Soydon' of Melcomb, Thomas Hullard of Shirburn, 'diere,' Simon Hullard of Dorchestre, Thomas Carpenter of Shirburn, John Wastel of Shirburn, John Dodde of Shirburn, Robert Bourt of Shirburn, John Shoyere of Shirburn, Walter Chepman of Shirburn, Robert Soutere of Mulborn, William Muryel of Shirburn and others, at Evercrich, co. Somerset, carried away his goods while so in protection, trod down and consumed with cattle his crops and grass and assaulted his men and servants. . By K.

Cornwall, detained him in prison at Wolleston until he made a fine of 10 marks with John Bevyll for his deliverance, broke his close, houses and chests at Hilscot, drove away three mares and a cow of his, worth 10*l.* there and carried away his goods, 10*l.* in money by tale and his deeds, writings and other muniments there.
