Dec. 1. *Inspecimus* and confirmation to the abbot and convent of Bruerne Westminster. of the following;—

- (1) Deed of Gilbert de Clare son of Gilbert de Clare, earl of Gloucester and Hertford, dated at Teukesbury, 31 December, 1313, and witnessed by Sirs Roger Tyrel, Gilbert de Sancto Audoeno, Giles de Bello Campo, John de Haustede, knights, Richard de Rodeny, steward of the honour of Gloucestre, Geoffrey Marshal, Reynold Aylewy, Peter Bascle, Roger de Stalham and others, inspecting and confirming a deed of Sir Richard de Clare, sometime earl of Gloucester and Hertford, his grandfather, dated at Hampton without Kyngeston, Monday after the octaves of Easter, 1246, and witnessed by Sir William de la Ware, then steward of the honour of Gloucestre, Sir Geoffrey de Fanecourt, Sir Geoffrey de Langele, Sir Nicholas de Noers, Sir Bardulf de Cesterton, Sir Gilbert de la Hide, Master Robert de Evereus, Walter de Swafham, Roger Golaffre, John de Gardino, Ralph le Clerk of Schipton, and many others, confirming grants to the church of St. Mary, Bruern, and the monks serving God there, by William de la Mare, Thomas de la Mare, William Tyilly, Gervase Malherbe, Adam Pygace, Ellis de Cundicote, William the Chamberlain, William de Maundevill, Alan the Chamberlain, Ralph son of Geoffrey, Thomas Rasur, Thomas Briton, Stephen de Harnhull, Matthew le Sexne, of lands &c. in Overerindecombe, Pridie, Hunchewyk, Estlech, Shorthampton Feldham, Middelton, Burton, Cercell and Cercendene, and granting further to the said monks that they be quit of all suits of hundreds, law-hundreds and courts pertaining to him or his successors in respect of those lands, that he will not distrain or suffer them to be distrained for any service, default of custom, suit or forfeiture of the superior lords of those lands, or their heirs or assigns, that they shall not henceforth be held to summon Richard de Cotes, or his heirs or assigns, on account of any suit of the hundred or court of Fairford, and that they shall be quit of all tolls throughout his lands and have full liberty to pass to and fro through the same lands with their cars, ploughs and carts, (his corn and meadows when these are in defence, excepted), and if they or their men shall forfeit in this respect, then fine shall be made by view and consideration of good and lawful men without delay, pleadings or contention.
- (2) Deed of Robert de Evercy, witnessed by Walter de Aura, Richard des Crupes, William de Fihide, Robert le Poer, Walter le Hont, Hamo de Baudynton, Gervase, his son, Robert de Spechel, Robert le Clerk of Eicot or Yete, Thomas Taillard, Roland Walter, palmer, and others, granting in frankalmoin to the same monks, for the souls of his father, mother, Agatha, his wife, and Robert de Everci, his son, his mill of Ablinton and lands and messuages there, free of all services, suits, homages, fealties, customs and secular demands, saving only scutage, all which lands &c. he will warrant to them against the bishop and convent of Worcester and the king.
