- Oct. 18. Appointment, for one year, of the king's yeoman, Richard de Westminster. Skarghill, the king's ferreter, to purvey conies in warrens, and fish in fresh waters, stews, lakes and stanks, for the king's money to be paid in the wardrobe, and to take thread for making and repairing nets to take the same, and carriage to take them to the places where the king's household is held. *French.*
- Oct. 18. Presentation of Edmund Bardolf to the church of Boyton, in the Westminster. diocese of Salisbury, in the king's gift by reason of the lands late of Wencelina Mautravers, who held in chief, being in his hand by her death. By p.s.
- Oct. 5. Grant in fee to William de Wykeham, bishop of Winchester, William Westminster.
