May 16. Licence, for 6s. 8d. paid to the king in the hanaper by Richard
Westminster. de Tyssynton, king's clerk, late parson of a mediety of the church of

messuage in Wodeford, not held in chief as has been found by an

May 20. Licence, for 10l. paid to the king by Nicholas de Stafford, 'chivaler,'
Westminster. for Hugh, earl of Stafford, to grant to him two messuages, a carucate
of land, 10 acres of meadow and 10 marks of rent in Gretton and
Tyllyngton, and a moiety of the manor of Norton on 'les Mores,' co.
Stafford, with a moiety of the water-mill of the manor, held in chief,
to hold for life at the rent of 4 marks.

May 28. John Swynesheved of Coventre, merchant, staying in England, has
Westminster. letters nominating Nicholas Holme of Coventre, merchant, and Walter
Douncrwe of Trymme in Ireland as his attorneys in Ireland for one
year. Thomas de Newenham received the attorneys.

May 26. Presentation of the king's clerk, William Riche, chaplain, to the
Westminster. chantry of the altar of St. Katharine in Burnham abbey, in the diocese
of Lincoln, in the king's gift by right devolving to him by lapse of time
