- Sept. 3. Exemption for life of Alan le Norreys of Speek from being put on assizes,

- Aug. 22. Notification that the king has seen fit to revoke his late collation of the
Perth. prebend of Wetewang in the church of St. Peter, York, to Walter de Wetewang, king's clerk. By p.s.
