of an enrolment of a charter in the rolls of the exchequer of Edward I, whereby it was found that in 1252 the said Payn granted to the abbot and convent and their successors his lands in Great Lymbergh, at the rent of 10 marks, for the king by reason of the forfeiture of the said Payn; and the abbot in his pleadings alleged that Payn son of Saier de Heleye, who is the same Payn named above, in 1 Edward I, when he was and long had been of the peace and allegiance of that king, by a charter shewn in the exchequer granted to the then abbot and convent the said land to hold in frank almain, rendering to him for his life only 10 marks yearly which rent was extinguished by his death in 31 Edward I, and whereas on view of such charter it is found that this is so the king ratifies the same, and for a fine of 50 marks made with him has quit-claimed all manner of action he might have against the abbot and convent by reason of the rent, that they from henceforth may be wholly discharged of the same. Feb. 10. Exemplification, at the request of the abbot of Neubo, of a certificate  
Westminster. by the treasurer and barons of the exchequer as follows:—a record before the said barons of Easter Term, 19 Edward III, Nottingham, to wit. The king by writ of great seal, dated 20 April in that year, commanded the treasurer and barons that whereas in the Parliament held at Westminster on Wednesday after Midlent Sunday, 14 Edward III, it was agreed that the religious men and other ecclesiastics who were not summoned to that Parliament nor granted the ninth of sheaves, fleeces and lambs to the king along with the prelates, earls, barons and commonalties assembled therein, and who paid the tenths previously granted to the king on the temporalities annexed to their spiritualities which were taxed to the tenth in 20 Edward I, should be wholly discharged from the ninth in respect of such temporalities and that in respect of land acquired since that year the ninth and wool in lieu of such ninth for the second year of the grant should be levied and whereas the abbot of Neubo was not summoned to that Parliament, they were to cause execution of a summons of the exchequer against him for the said ninth to be stayed. And now at the quinzaine of Easter the abbot, by Richard de Houton, his attorney, complains that he is distrained by the sheriff for 37s. 9d. of the said ninth. And upon this it
