Appointment of Robert Ledred, Robert Andreu, Thomas Moys and John Twyneham to go upon the sea to convoy merchandise and victuals to and from Flanders and Calais, and to guard the passage by sea from the port of Ravensere as far as Hildernessee, and 'le farewaye' between the said places and Flanders, so far as the wind will permit; and to take in any port or place of the realm such mariners and archers as are necessary for the convoy, with power to arrest and commit to prison contrariants. The king gives to them whatever in such progress they can acquire or gain from his enemies on the sea. By K. on the information of the treasurer.

Although in letters patent to John de Bello Campo of sums granted to him by the king it is contained that there has been granted to him for his fee for his stay with the king 80*l.* and for maintenance of his estate of banneret 160*l.* and that of such 240*l.* there has been assigned to him 20*l.* in the New Forest, 53*l.* 6*s.* 8*d.* on the customs in the port of London, yearly for his life, and 166*l.* 18*s.* 4*d.* of the farm, which Margery late the wife of William de Roos of Hamelak renders to the king for the keeping of lands in the counties of Lincoln and Northumberland, committed to her by the king during the monage of the heir of Adam de Welle, tenant in chief, yet because it is clearly shewn to the king that he has granted to the said John for life, 20*l.* by reason of the order of knighthood received by him in the seventeenth year, 60*l.* for good service and specially because of his bearing the king's standard at the battle of Cressy, on 26 August, in the twentieth year, and 200*l.* to support the estate of banneret and for his stay with the king, on 1 March, in the twenty-third year, by word of mouth, which sums amount to 280*l.* in the whole, whereof the 20*l.* which he receives yearly in the New Forest are not parcel because these were given him by Queen Philippa, at the king's request, for another cause: the king, on surrender by the said John of the letters patent aforesaid, assigns to him the whole 280*l.* to wit 140*l.* yearly out of the customs of the port of London and 140*l.* yearly out of the customs in the port of Boston, for life or until he provide him with an equivalent of land and rent.
