- Mandate to the justiciary and treasurer of Ireland to let the said Peter have 50 marks out of the issues of the king's lands in Ireland, in compensation for two destriers which he lost in the king's service at Kannok.
- May 6.
Westminster. Safe-conduct, for one year from Whitsunday next, for John de Sancto Govesio, merchant of Genoa, coming to England with merchandise.
- Licence for William de Lancastre to make his will of such goods as it is the custom of the realm to make a will of.
- May 8.
Westminster. Bond to Randolf Ern[aldi], William Artus and Amanieu Bonafus, merchants of Bordeaux, in 500 marks, which Aaron Jew of York, borrowed from them to the king's use by the hand of John Maunsel, payable to the merchants on the octave of Holy Trinity next unless Aaron pay them before; and if they sustain any losses by default of payment at that date the king is bound to make good such loss if Aaron do not.

- May 8.
Croydon
(Cruellen) Power to John de Grey, justice of Chester, to conduct to the king the envoys of Griffin son of Owen, Llewelin his brother and other Welshmen, or their envoys, if any will come to treat of peace, until a week after Midsummer next.
- May 12.
Canterbury. Licence for Simon de Campis, merchant of Duay, to trade in the realm; so that no prise be made of his cloths in the coming fair of Boston and for three years following.
- Grant to Robert de Mucegros of the wardship, during the minority of the heir, of the land and heirs of Geoffrey Esturmi, with the marriage of the heirs and all escheats falling in.
- May 14.
Dover. The prioress and convent of St. Edward's, Shaftesbury, have licence to elect, by Wimark[a] Cusin and Emma de Portibus, sisters of that house.
- May 16.
Canterbury. Presentation of Master Walter de Lench to the church of Gretham, in the king's gift by reason of his custody of the land and heir of Roger Bertram; directed to the bishop of Durham.
- Appointment of the sheriff of Kent and Henry de Winge ham to enquire by oath of good men what customs and rights of the king have been withdrawn in the town of Sandwich, from what time, by whom and who holds them.
- May 20.
Rochester. Grant to the infirm of the hospital of Rochester of a livery of 1*l.* a day and 10*s.* a year for cloths, which livery Alfere the Hawker (*accipiturius*) used to have at Middelton, receivable by the hands of the sheriff of Kent from his farm at the same four terms as Alfere used to receive it, as a charter of Henry I, which the said infirm have thereof, testifies.
- May 22.
Westminster. Pardon to Nicholas de Frakeham for the death of William son of Reginald de Mepeham, as it appears by inquisition that he killed him by misadventure; granted on condition that he stand his trial, if any of the relatives of the said William will proceed against him.
- Mandate to the sheriff of Kent to deliver him out of the king's prison.
- May 23.
Westminster. Grant to Roger de Whitcestre of 10*l.* a year at the Exchequer, so long as he keep the rolls and writs at the Bench, London, to maintain him in the king's service.
