*Membrane 5—cont.*

Assignment to Philip Basset, justiciary of England, of 1000 marks a year at the Exchequer, during pleasure, to maintain him in the said office.

Writ *de intendendo* for the said Philip, whom the king has appointed to be chief justiciary of England for his own preservation, the tranquility of the realm, and the showing of justice to all; directed to all persons of the realm.

Mandate to constables and keepers of the castles of England to permit the said Philip to enter the said castles when he passes that way or has need to enter, and to receive therein such prisoners and disturbers of the peace as he causes to be arrested and sends to be kept in the castles, and to keep such safe until further order from him or the king.

Signification to the pope of the royal assent to the postulation of Patrick, bishop of Raphoe (*Ratboten'*), to be archbishop of Armagh.

Aug. 14. Windsor. Mandate to Bertrand de Cardillac, seneschal of the Limousin, Quercy and Perigord to deliver the said lands and castles to John de la Lynde, king's marshal, the bearer to keep during pleasure, as for many causes the king has at present to provide for the state and tranquility of the said lands.

Aug. 14. Windsor. Writ *de intendendo* for him directed to all persons of the said lands.

Aug. 14. Windsor. Mandate to the prior of St. James, Bordeaux, to collect the arrears in Gascony of bequests in aid of the Holy Land, of the money of Crusaders and indistinctly bequeathed; which amount to 1000 marks, and belong to the king by grant of the pope; and thereof to pay to William de Talyva 300 marks in part payment of what the king owes to him, and to keep the residue until further order.

The like mandate to him by letter close.

Aug. 15. Windsor. Grant to Bozo de Burdeyl, who has now put himself, his lands and his tenements, which he held before in his own right (*in alodio*), under the king's lordship, and received his lands to hold of the king, and done his homage for them to the king; of 30 marks a year at the Exchequer, for his maintenance in the king's service.

Aug. 14. Windsor. Presentation of John de Colecestre, king's chaplain and almoner, to the church of Kelmon, void by the death of John de Bermigford, late rector, and in the king's gift by reason of the voidance of the archbishopric of Armagh; directed to the bishop of Meath, with a request that he shall admit the said John notwithstanding any former order for the provision for any other.

Grant to Robert de Sancto Johanne that he may fortify with a paling his house at Basing upon his dyke now thrown up (*exstructa*) there, and keep it so fortified at the king's will.

Grant to Peter Parag', whom the king, when last in Gascony punished for his delinquencies by excluding him from the town and *banlieu* of Bordeaux for five years, that that term completed and the king's injunction observed, he may return home.
