The like for Master John de Perouges, parson of the church of Charing.

Whereas the king heretofore granted to Henry, artiller of the catapults (*balistarum*), then dwelling at Windesor, that as regards the *5d.* a day, which he had hitherto taken for his wages by the hands of the constable of that castle at will, he should take the same for life by the hands of the said constable, together with his robes from the wardrobe, as he had before ; and whereas the king now wills that he stay in the castle of Gloucester and exercise his office there, for his life ; grant to him of the said *5d.* a day, for life, by the hands of the sheriff of Gloucester, with his robes which he has been accustomed to have yearly from the wardrobe.

Oct. 5. Windsor. Signification to the pope of the royal assent to the election of Richard de Harewes, canon of Wautham, to be abbot of that place.
The like to the college (*cetui*) of Cardinals.

Pardon to John son of Fulk de Cokfeld for the death of Isabel daughter of Laurence de Cokfeld ; as it appears by inquisition made by Robert Fulconis that he killed her by misadventure.

Oct. 7. Windsor. Simple protection, without clause, for five years, for John de Whetlay.

Oct. 9. Merton. Grant to John le Convers, serjeant at arms, to whom the king granted *6d.* a day which Richard le Normaund had during his life by the hands of the bailiffs of Cocham and Braye, that he shall have the said *6d.* a day by the hands of the bailiffs of Braye, Windesor and Kenynton, as the king has given the manor of Cocham to the queen.

Signification to R. bishop of Lincoln, of the royal assent to the election of William de Shepved, prior of the house of St. Mary de Pratis, Leicester, to be abbot of that place.

Grant to Alan de Depe and Hawise his wife, merchants, to whom he has granted that they may follow the court with their goods and merchandise, and stay in it, and that they may seek wares over the realm and bring them to court, as shall be expedient, that they may buy wares throughout the realm and trade with the same and the wares which they have bought and sold they shall have quit of stallage, tallage and murage in all places of the realm, wherever they happen to lodge in towns, cities, or boroughs for such time as they will follow the court and trade there.

Oct. 16. Westminster. Confirmation of a grant by John de Sancto Johanne, knight, to Philip le Taylur, citizen of London, and Sabina his wife, of the manor of Erde, co. Kent, for their lives, with the advowson of the church thereof and all other appurtenances.

Oct. 19. Westminster. Protections for the crusaders :—
Protection with clause *volumus*, for four years from embarkation, for Edmund, the king's son, going beyond seas in aid of the Holy Land, and for his men, lands and possessions.
