main to them 2 messuages, 2 tofts, 45 acres of land, 2 acres of meadow, 4 acres of wood and 2s. rent in Goldyngton, not held of the king, in aid of their maintenance.

March 7. Grant to the king's servant William de Lynne, in lieu of a grant
Westminster. to him by letters patent dated 23 February, 1 Henry IV. (*see Vol. I. p. 219*), surrendered, of the said lands in the town of Ware to hold from that date so long as they remain in the king's hands without rendering anything to the king; as the barons of the Exchequer have charged him to account for 17s. 10d. yearly surplus beyond the said 4 marks yearly, although he cannot raise more than 40s. yearly from the lands. By p.s.

March 3. Pardon to John de Burton, late sheriff of Nottingham and Derby,
Westminster. of 100 marks from what is due from him to the king because of his office, in consideration of the great losses sustained by him in office because of divers liberties granted to the king's consort the queen and other persons within the said counties and on account of the late raging pestilence in them. By K.

March 2. Grant for life to the king's esquire John Emond of 20l. yearly from
Westminster. the issues of the manor of Horstede, co. Norfolk, so long as it remains in the king's hands on account of the war with France, as James Billyngford had while he lived. By K.

Vacated by surrender and cancelled, because with his assent on 14 May the king granted the same to Thomas Erpyngham from Easter last.

April 16. Grant to Robert Burgh, parson of the church of Asfordby, outlawed
Westminster. at the suit of Roger Helmeswell, vicar in the cathedral church of Lincoln, of all his goods forfeited to the king to the value of 100s. By p.s.

April 13. Pardon to Robert Burgh, late parson of the church of Asfordeby,
Westminster. for all treasons, insurrections, rebellions, felonies, offences, misprisions, impeachments and trespasses committed by him before the Conversion of St. Paul last except murders and rapes, provided he be not a notorious approver, a thief nor in prison for larceny. By K.
Vacated because in the roll of pardons for this year.

Aug. 20. Revocation of the protection with clause *volumus*, for one year,
Westminster. lately granted by letters patent to Walter Pafford, going on the king's service in the company of the king's brother John, earl of Somerset, captain of the town of Calais, on the safe-keeping of the same, because he delays in the city of London, as the sheriffs have certified.

Westminster. *alias* Skelton in the collegiate church of Rypon. By p.s.
