- Nov. 5. Presentation of Henry Saltwode, parson of Sulbury, in the diocese of Westminster. Lincoln, on an exchange of benefices with Thomas Pityngton, to the chantry at the altar of St. Mary, in the cathedral church of Canterbury, founded by Sir Edward, late prince of Wales.
- Nov. 7. Commission to John Hille, serjeant of the larder, and John Blacwell Westminster. to take and provide the carriage necessary for the office of the larder.  
By bill of the treasurer of the household.
- Nov. 8. Grant, during pleasure, by advice of the council, to Edward Stradlyng, Westminster. king's knight, of the office of steward and receiver of the lordships of Cantreselly, Alsandreston and Penkethly, which are held of the earl of Hereford, the said office of steward and receiver of the king's lordships having been previously held as one office, with the fees of 40s. [a year].

Grant, during pleasure, by advice of the council, to Ralph de Kellermer that he be clerk of the statute-merchant within the town of Wygan, and have the keeping of the lesser piece of the king's seal for recognisances of debts according to the form of the statute-merchant appointed for the said town, with the usual fees. - Nov. 13. Licence for the prior and convent of Athelneye to elect an abbot in Westminster. the room of John Brygge, deceased.
- Nov. 12. Grant, during pleasure, by advice of the council, to Lewis Gethyn, Westminster. burgess of Kermerdyn in South Wales, of the office of clerk of the county and petty sessions within the counties of Kermerdyn and Cardigan, with the usual fees and wages. By p.s.
- Nov. 8. It has been shown to the council by Elizabeth, wife of William Westminster. Ryman, that king Henry V, both by his own letters and by mandate given on his behalf by the duke of Gloucester, commanded the said William and Elizabeth that she should come to that king in his realm of France to do service about the person of the present king's mother; the said Elizabeth accordingly came to the said late king at Paris, and attended the present king's mother until he was born: at which time the said late king charged the said Elizabeth to watch and attend on the present king's person; which service she has continually performed without fee or reward to her importable charge, and the great derogation of her husband and herself. The king considering the premises and her services to his father and mother, whereby she has fallen into such infirmity, old age and weakness that she can no more labour, by advice of his council, has granted, during pleasure, to the said Elizabeth 20*l.* a year out of the fee farm of the town of Notyngnam, by the hands of the mayor and bailiffs there; notwithstanding that she has, by grant of Henry IV, 20*l.* a year for life out of the issues and profits of the county of Norfolk; and, by grant of Henry V, confirmed by the present king, the manor of Oldeshorham, co. Sussex, for life. By p.s.
- Nov. 14. Licence for the dean and chapter of the cathedral church of Wells, and Westminster. to the prior and convent of the cathedral church of SS. Peter and Paul, Bath, to elect a bishop in the room of Nicholas, deceased. By p.s.
- Nov. 20. Presentation of William Calthorp, parson of St. Clement's, Saltfleteby, Westminster. in the diocese of Lincoln, to the chantry called 'Ravenserchantery,' in the cathedral church of St. Mary, Lincoln, in the king's gift by reason of the temporalities of the bishopric of Lincoln being in his hands, on an exchange of benefices with William Broun.
