Dec. 9. *Inspecimus* and confirmation, by advice and assent of the lords spiritual and temporal and of the commonalty of England in the Parliament held at Westminster in the king's first year, to the wardens of the king's exchanges, and to the workers, moneyers and other ministers deputed for purposes belonging to the office of the said exchanges, of letters patent dated 24 December, 1 Henry V, inspecting and confirming letters patent dated 16 December, 1 Henry IV, inspecting and confirming letters patent dated 10 February, 1 Richard II, inspecting and confirming letters patent dated 4 March, 5 Edward III, inspecting and confirming letters patent dated 1 March, 2 Edward II. Dec. 12.
