Westminster. Grant to the bailiffs and good men of Tenebegh of quayage for two years.

Westminster. Presentation of John Kyng, chaplain, to the church of Burgham, in the diocese of Carlisle, void by the resignation of William Swetyng.
- Nov. 26.
Westminster. Licence for the prior and convent of Derby to elect an abbot in the room of Simon de Repyngdon, deceased.
- Nov. 26.
Westminster. Grant, during pleasure, to Thomas Broune of the office of tronage and pesage in the port of London, with the usual fees, wages and profits.

Westminster. Robert Darcy, esquire, John Aburhale, esquire, William Ulgarthorp, esquire, William Eton, clerk, John Boneyr, clerk, John Horewode, John Boreham and William Parker lately acquired to themselves and their heirs from Richard Grey of Wilton, knight, the manors of Water Eton and Waterhall, co. Buckingham, which are held of the king in chief, and afterwards granted the premises to John, son of the said Richard, and Elizabeth, his wife, and the heirs of the bodies of the said John, the son, and Elizabeth, with remainder to the right heirs of the said Richard. The parties entered in the premises without licence, but for 40 marks paid in the hanaper the king has pardoned these trespasses and licenses the said John and Elizabeth to retain the premises.

Westminster. Pardon to Henry Banastre of Suthwerk, co. Surrey, 'gentilman,' of his outlawry in the county of Middlesex for not appearing before the justices of the Bench to pay the king the ransom due for a trespass which he was convicted of having done to Thomas Feryby, clerk. The said Henry has surrendered to the Flete prison and the said Thomas has acknowledged payment of the damages adjudged to him for the said trespass, as William Babyngton, chief justice of the Bench, has certified.

Westminster. Grant to the mayor, bailiffs and good men of the town of Bristoll of murage for ten years, with exemption for the men and tenants of Humphrey, duke of Gloucester, of his town of Teneby in Wales.
