June 3. Grant, for life, to Robert de Bitterle of the place of a poor knight of Westminster. the college of the king's free chapel of St. George in Windsor Castle which Thomas Tanny, deceased, had. By p.s.
- May 1. Licence for John, bishop of Lincoln, to make two prebends of the Westminster. parish churches of Sutton by Markeby, in the archdeaconry of Lincoln, valued (*taxata*) at 18½ marks yearly, and Kildesby, in the archdeaconry of Northampton, valued at 10 marks yearly, both of his patronage and parcel of the endowment of the see, and to unite the same to the dignities of the precentorship and chancellorship in his cathedral church of St. Mary, Lincoln, which are so slender that scarcely any persons are willing to accept them on account of the burden of supporting them. By p.s.
- June 14. Grant to James de Pykeryng, knight, and John de Yorke, in aid of the Westminster. repair of the bridge of Strangerwaith over the water of Lone, of pontage, for three years, from things saleable coming from the priory of Hornby to the bridge called 'Lonesbrig' over Tybay, in the county of Westmoreland.
- June 17. Presentation of John de Watltham (*sic*) to the church of Grendon, in Westminster. the diocese of Lincoln.
- June 20. Grant to the prior of St. Saviour's, Holandbrigge, of pontage, for two Westminster. years, for the repair of the said bridge.

- May 10. *Inspeximus* and confirmation, in favour of the abbot and convent of St. Westminster. Thomas the Matyr, Dublin, of a charter dated Westminster, 26 November, 4 Edward III. [*Charter Roll, 4 Edward III., No. 27*], inspecting and confirming a charter dated Assherugge, 14 January, 19 Edward I. [*Charter Roll, 19 Edward I., No. 54*], inspecting and confirming divers charters and letters patent of Henry II., and William, his steward (*dapifer*), King John and Walter de Lacy. [*Gilbert's Register of the Abbey of St. Thomas the Martyr, Dublin, p. 11.*] For 100s. paid in the hanaper.
- May 28. Appointment of Thomas Graa, John Pathorn and John Quixlay to Westminster. repair the head (*capud*) of the king's stew of Fosse beneath the castle of York and of the mills there, by survey and testimony of the sheriff of York and John de Barden, keeper of the stew. By bill of p.s.
- June 2. Exemption, for life, of Robert de Whiteneye, knight, from being put on Westminster. assizes, juries, attaints or recognisances, and from being made mayor, sheriff, escheator, coroner, taxer, assessor or collector of tenths, fifteenths or other subsidy, bailiff or other minister of the king against his will. By p.s.
- May 20. *Inspeximus* and confirmation, in favour of John de Wydeford, clerk Westminster. in the avenary of the late king, retained, of letters patent dated 8 March, 39 Edward III., being a grant to him, for life, of 100s. yearly at the Exchequer. By p.s.
- May 20. Grant, for life, to Walter Worth of the custody of the king's manor Westminster. of Claryndon, with 4*d.* daily out of the issues of the county of Wilts, at the supplication of John de Wydeford and on his surrender of letters patent dated 4 December, 41 Edward III., and the king's confirmation thereof, being a grant of the premises to the said John for life.
